We continued to keep our doors open, welcoming new people into our services. The Bello Machre family, including our direct support professionals, the maintenance team, and the administrative staff, came together, exceeded expectations, and thrived!

Bello Machre means *Home of My Heart* in Gaelic.

We provide homes and support to children, teens, adults, and seniors with developmental disabilities. More importantly, we provide a lifetime commitment to enrich the lives of those we serve through loving care, guidance, and opportunity.

Employing over 390 skilled professionals, we have the capability to serve 190 people in 50 community homes throughout Central and Western Maryland. Bello Machre also provides help and support to more than 200 children, adults, and families in their own homes and communities.

The Hertha and Jesse Adams Ray of Hope Program helps families by offering assistance with expenses such as specialized summer camp, physical therapy, and adaptive equipment. Trained and caring staff provide residential respite care during family hospitalizations, emergencies, and vacations — 24-hours a day — seven days a week.

The Meaningful Day Program provides individualized day services including supported employment; job development and training; and community-based social, recreational, and educational opportunities. Our goal is that each person we support be engaged in all aspects of community life throughout Maryland.

Bello Machre is there to help with whatever is needed, empowering people with developmental disabilities to live life to its fullest.

Bello Machre is a 501(c) (3) organization registered with the State of Maryland Secretary of State, regulated by the Maryland Department of Health, and licensed by the Maryland Office of Health Care Quality. We serve children, adults, and families without regard to race, religion, gender, or national origin.

Growth, adaptation, and financial fortitude were the pillars on which we stood in 2021.

Bello Machre quickly adapted to the ever-evolving nature of the pandemic and the ever-changing needs of the people we support and the staff who care for them. “We adapted to mandates and restrictions by being creative in how we provided services. We utilized Zoom technology for virtual services, outdoor spaces for activities and visits, and iPad technology to those in remote settings — to name a few examples,” says Julie Provan.

Additionally, Bello Machre completed its digital transformation with the implementation of iCare Manager — a cloud-based software system that provides our direct support professionals with real-time, remote access, and paperless documentation for people in our services. This technology continues to enhance care and opportunities across all our service platforms.

Looking to the future and the increasing demand for our services, Bello Machre identified two strategic initiatives — recruitment and marketing — to address the need to find and keep great employees and to expand the ways in which people reach and hear about Bello Machre. “We are already seeing early success in hiring great staff and outreach through social media engagement,” says Dr. Ireland.

Throughout the year, Bello Machre harnessed state and federal emergency resources, finding and successfully applying for all available COVID-19-related funding opportunities. Doing so, we were able to provide our employees job security incentives, equipment for virtual services, and unlimited personal protective equipment.

To increase access and outreach to the Bello Machre family and community, we took the initiative to become a vaccination site. Across the three vaccine clinics, 800 people were vaccinated on our campus this spring. The outreach included people in our services, Bello Machre employees, and family members of those we support. We followed up with two successful booster clinics in the fall.

Dr. Ireland concludes, “As we close out 2021, we realize we could not have made it through another very challenging year without the support of our resilient employees, generous grant partners, steady volunteers, and dedicated donors. **Thank you all for being a part of the Bello Machre family.** 🌸

So Much More than a Job!

They call themselves the *Run Abouts*, a group of individuals supported through our Personal Supports Program who “Run About” doing exciting things in the community. Darlene is the direct support professional for Bello Machre who organizes this crew. Clifton, 55 years old; Katie, 45 years old; Gail, 39 years old; and Aaron, 36 years old, have been together for almost 13 years.

Those many years ago, Darlene discovered it was much more than just caring and supporting the individual. She was helping the people she supports interact with their peers, experience friends, and navigate life. Darlene says, “They can’t do that if it’s just me and the individual. They all would much rather be together with their friends than spend time with me. If I was just supporting one person at a time, these friendships would not develop. Each one of them learns from their peers, watching how each other reacts to a situation. They look up to each other and have developed a deep bond and friendship. I say I’m just the taxi driver.”

In addition to getting out in the community swimming, bowling, and going to dances, Darlene has opened her home to the group so they would always have a place to gather, enjoy a meal, play games, watch movies, and hang out. “We have become a family,” Darlene shares, “It has been the joy of my life watching these friendships grow over the last 13 years.”

Gail share, “Darlene is a very special person to me — because she is like family to me — because she is so sweet and loving and she loves us so much.”

When hanging out at Darlene’s home, the group enjoys movie nights, arcade and board games, the Wii, and everyone’s favorite, the firepit and roasting marshmallows.

This past year has been tough for the Run Abouts not being able to gather and do the activities they love. However, with the support of the families, Darlene worked her magic to ensure these four friends could socialize and be together. “My home is set up so we could eat at separate tables and social distance when watching movies,” Darlene shares. “We can’t wait to get back to the monthly dances, group bowling, going out for pizza, and seeing our friends,” Katie shares.

Darlene concludes, “*It’s so much more than a job. Seeing these friends thrive through life experiences fills my heart with joy.*” 🌻

Woody loves *everything* sports. His room is painted purple for the Ravens. He always wears a local teams sports jersey, and he loves attending Xavier’s high school soccer games.

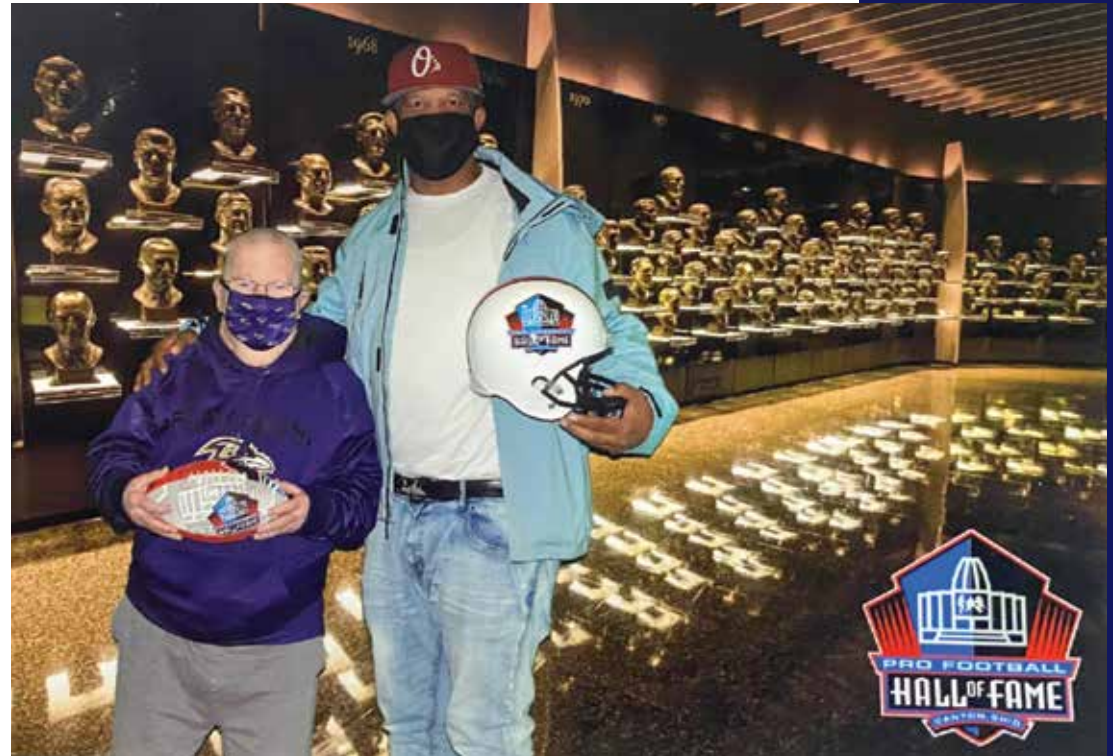

Generous Community Grant Partners

Our amazing grant partners awarded \$327,355 through numerous funding opportunities. Grants to Bello Machre are critical to help bridge the gap between government funding and the cost of providing loving care and opportunities to the hundreds of people we support. Our 2021 grantors prove again that we are part of a very generous community.

Phillips Charitable Foundation awarded Bello Machre with a \$116,500 grant to be used as the down payment for Bello Machre's next state-of-the-art, fully-accessible home, which will be named in honor of Howard W. Phillips, Jr., the namesake of the Phillips Charitable Foundation. Located in Hanover, MD, the property will be the forever home for four adults in critical need of accessible housing. An open house and dedication to take place in Spring 2022.

Arundel Community Development Services provided a very generous community support grant in the amount of \$21,569 to purchase iPads to provide virtual services to individuals within the Bello Machre Community Services Program who were unable to receive traditional services due to the COVID-19 pandemic. With the iPads individuals were able to FaceTime and Zoom with family and friends during shelter-in-place and stay-at-home orders, as well as self-isolation and quarantine, helping maintain a sense of normalcy while keeping our people safe.

Hertha S. and Jesse L. Adams Charitable Trust continued with their gifts totaling \$54,065 in support of the Hertha and Jesse Adams Ray of Hope Program, helping families in our community and individuals we support with unfunded items such as physical and occupational therapy, co-pays for medical appointments, prescription medication, summer camp expenses, adaptive equipment, and transportation to out-of-state specialists.



Thank You Phillips Charitable Foundation!

Kathy and Jerry Wood Foundation continued its support of the Bello Machre Meaningful Day Program with a \$25,000 grant. This grant helps young adults with developmental disabilities obtain job skill training and community job placement.

Maryland Affordable Housing Trust announced in December 2021 a grant award to Bello Machre in the amount of \$58,196. These funds, expected in 2022, will be used to purchase four, full-home generators for our homes at St. Stephens Church Road, Opel Road, Elm Avenue, and Central Lane.

Maryland Community Health Resources Commission generously awarded Bello Machre with a \$48,100 DDA Emergency Relief grant to respond to the impact of COVID-19 and to continue providing our services. With these funds, Bello Machre initiated and awarded 330 employees who successfully maintained employment and worked their designated shifts to maintain and reopen services a one-time, retention bonus of \$150.

Maryland Developmental Disabilities Council awarded Bello Machre with an Engagement and Connection during the COVID-19 Pandemic Grant in the amount of \$3,925 to purchase iPads to provide virtual services to individuals in the Community Services Program in Carroll County, enabling individuals to connect, engage, and participate in activities with staff and other individuals within the program and in their communities.

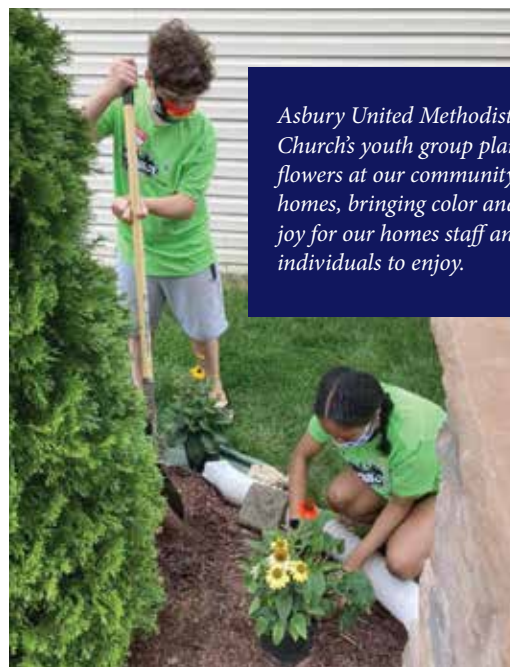
