– Debra Wade Mattie's mom Bello Machre means Home of My Heart in Gaelic. We provide homes and support to children, teens, adults, and seniors with developmental disabilities. More importantly, we provide a lifetime commitment to enrich the lives of those we serve through loving care, guidance, and opportunity.

Employing over 350 skilled professionals, we have the capability to serve 200 people in 60 community homes throughout Central and Western Maryland. Bello Machre also provides help and support to more than 150 children, adults, and families in their own homes.

The Hertha and Jesse Adams Ray of Hope Program helps families by offering assistance with expenses such as specialized summer camp, physical therapy, and adaptive equipment. Trained and caring staff provide residential respite care during family hospitalizations, emergencies, and vacations — 24-hours a day — seven days a week.

The Meaningful Day Program provides individualized day services including supported employment; job development and training; and community-based social, recreational, and educational opportunities. Our goal is that each person we support be engaged in all aspects of community life.

Bello Machre is there to help with whatever is needed, empowering people with developmental disabilities to live life to its fullest.

Bello Machre is a 501(c) (3) organization registered with the State of Maryland Secretary of State, regulated by the Maryland Department of Health, and licensed by the Maryland Office of Health Care Quality. We serve children, adults, and families without regard to race, religion, gender, or national origin.

Our programs and services continue to grow with offices in both Anne Arundel County (serving Central Maryland) and Carroll County (serving Western Maryland).


Bello Machre expanded its Support Services Program in Central Maryland by 15 percent with 20 additional people now receiving services in their family homes. We saw a desperate need for service and launched our Support Services and Meaningful Day Programs in Carroll County. These programs are up and running and now serve 18 people.

The growth of all of our Support Services and Meaningful Day Programs helps those we support stay in their family home for as long as possible. They also offer a natural stepping-stone to Bello Machre's vast services and promise of a lifetime of loving care.

As people with developmental disabilities live an almost average lifespan, Bello Machre must be ready to support them in every aspect of their lives. "We are committed to providing beautiful, fully wheelchair-accessible homes where people with developmental disabilities will be safe and loved for their lifetime. Evaluating and replacing our older homes ensures that we will be ready to meet the accessibility needs of our aging population," says Julie Provan.

Bello Machre made significant strides broadening our community awareness through extensive social media and marketing efforts. These strides were fundamental in the success of our Every Step Counts event resulting in a record-breaking fundraising total of \$209,000. Additionally, after being nominated by a volunteer who is also a family member of someone we support, Bello Machre received its largest corporate donation of \$119,000 from the Exelon iTee Golf Tournament.

Mattie came to live at Bello Machre's Crest Lane home in Westminster, Maryland, to find a more independent life in the community. Challenged with intellectual disabilities and Down Syndrome, Mattie graduated from Westminster High School and completed two years at Carroll Community College.

"We are so proud of Mattie; her independence and friendships have blossomed since she moved to Bello Machre two years ago," says Debra Wade, Mattie's mom.

During the day, Mattie works at the Panera Bread in Westminster. When asked about her favorite part of the day she said, "I like vacuuming, cleaning tables, and putting dishes away. I like to help because I'm a very thoughtful person." When Mattie is not working, she loves to go to the movies, exercise, and swim at the YMCA.

The friendships Mattie has made with her staff and housemates are invaluable. Gary, Mattie's dad, says, "Mattie always wanted a best friend. Friends are so important to our emotional well-being and Bello Machre made this dream a reality for Mattie. We know she is living her best life and **she is so happy.** It makes our hearts sing!"

Supported by the Meaningful Day Program and her co-workers at Skyline, Kathryn continuously cultivates her professional career. She now fills in for the receptionist during lunch and has a regular speaking engagement at Skyline's New Hire Days. Amy explains, "Kathryn tells new hires about her life and how she came to work at Skyline. This helps her develop her public speaking skills and pushes her to grow."

In addition to changing her own life, Kathryn's work and presence at Skyline has profoundly impacted the lives of her co-workers. Amy adds, "Kathryn influences everyone in the organization to be the best they can be."

There were no pictures of him as he grew from a little boy to a middle-aged man or records of his life in an institution.

Clifford's life transformed when he came to Bello Machre in 1981. At the age of 46, he finally began to know what it feels like to love and be loved. "Clifford is devoted to his Bello Machre family! He is very social and thrives when he is with other people," explains Juanita Evans, Residential Program Manager.

Whether Clifford is participating in dance therapy, spending time with his housemates, or sharing stories about his Bello Machre scrapbook, he loves to be surrounded by joy and celebration. This summer, Bello Machre hosted a Campus Block Party and invited the employees and people who live in our homes to come out for a day of fun, games, music, and food. Juanita shares, "Clifford had a blast! It makes my heart smile to see him having an incredible time dancing and socializing."

Juanita comments, "As he ages, he's lost a lot of his eyesight and needs support when he is in unfamiliar environments. We work with him so he can keep his independence, but always have loving support to help him through challenges. He knows he will have a family at Bello Machre for the rest of his life."

GRANT PARTNERS The generous community grant partnerships continue to make a difference by helping to fill critical gaps in funding at Bello Machre.


