OUR MISSION

To provide a lifetime commitment of ***loving care, opportunity, and guidance*** for people with developmental disabilities in Maryland.



For over 50 years, we have provided residential and community-based services that help those we support live rich, fulfilling lives.

Employing over 475 skilled professionals, we have the capability to serve 180 people in 50 community homes throughout Central and Western Maryland. Bello Machre also provides help and support to more than 200 children, adults, and families in their own homes and communities.

The Jesse and Hertha Adams Ray of Hope Program provides assistance to help meet the needs of individuals and families. From specialized summer camp to physical therapy and adaptive equipment expenses, Bello Machre will help families no matter the challenges they face.

Personal Supports Services pair Direct Support Professionals with individuals in a one-to-one setting. The people we support receive access to community-based social, educational, and leisure activities, helping them to thrive and grow.

Meaningful Day Services include Community Development Services and Employment Services; both provide community-based adult day services. Community Development Services include social, recreational, and volunteer opportunities in a small group setting so that the people we support can be active members of the community. Employment Services focus on helping your loved one find competitive employment opportunities in the community.

Residential Services offer care for people in Bello Machre-owned homes where they feel safe and loved. A Family Living Director (house manager) and other Direct Support Professionals guide and help those we serve so they can grow, develop, and live life to the fullest.


TAKING CENTER STAGE AND EARNING BIG

They all wanted to do something special to honor the memory of their dear friend and fraternity brother, who passed away suddenly in 2020. Rick's late father, Frederick T. Ensor, Sr., was also an honorary Frostburg SAE brother. With the tournament in its 3rd year, Bello Machre was honored to be the recipient of its proceeds. OUR LEGACY FUND

The Bello Machre Legacy Fund plays a crucial role in ensuring our financial stability, long-term viability, and enduring impact. Our Legacy Fund giving includes bequests, Charitable Gift Annuities, planned giving, and memorial and honor gifts. These gifts accounted for more than \$308,000 from many generous donors. By encouraging donors to include charitable giving through their planned giving and estate plans, we can secure the resources we need to continue our vital work for years to come. Highlighted below are noteworthy contributions that were made to the Legacy Fund in 2023.

Income for Life

Charitable Gift Annuities make a life income arrangement for the donor which includes lifetime payments and tax savings. Two very generous Charitable Gift Annuities were received from **Dave Wynkoop** and **Audrey Miller**, both parents of individuals in Residential Services at Bello Machre. Both gifts also help to secure the future which gives parents like, Dave and Audrey, peace of mind knowing their children will have a home for life.

Leaving a Legacy

Estate gifts allow donors to ensure that their legacy reflects their passions, beliefs, goals, and values. In 2023, the Bello Machre Legacy Fund received gifts from the estates of **Mary K. Bryant**, **James L. Cutter**, **Ruth Hahn**, and the **Charles Irish Family**. The earnings and interest from the Legacy Fund help to secure our future and fund special projects while perpetually paying tribute to these extraordinary donors.

Rollover for Good

At the age of 73, a Required Minimum Distribution (RMD) from one's IRA is mandatory. Rolling over an RMD to Bello Machre provides tax advantages for donors, essential financial support for us, and opportunities for individuals to make a meaningful difference in their communities through philanthropy. Two generous RMD gifts were received from **Chet and Elaine Lawrence** and **Jo Beth and Bob Ireland** and placed in the Legacy Fund.

Honoring Lives

Fewer acts of kindness and giving yield greater satisfaction than a tribute gift to Bello Machre. All Honor and Memorial Gifts are placed in the Bello Machre Legacy Fund. This year, three gifts in excess of \$5,000 were designated in honor of the memory of loved ones: we thank the **Ensor Family**, **Jo Eberly**, and **Virginia Thomas** for their tributes.



Generous Community Grant Partners

Our amazing grant partners made numerous funding opportunities available for Bello Machre. Filling gaps in funding at Bello Machre, our 2023 grantors prove again that we are part of a very generous, enduring community.

Arundel Community Development Services, which administers grants through the Anne Arundel County Executive's Office, provided a generous community support grant in the amount of **\$15,000** to purchase start-up supplies for five new individuals admitted into our Residential Services program. With the funds awarded, we were able to provide bedroom furniture, bed linens, towels, and other necessary supplies to make our folks as comfortable at home as possible. The Anne Arundel County Executive's Office has generously funded \$116,000 for Bello Machre for eleven years."

Delta Dental provided a **\$10,000** grant for the start up of a dental pilot project designed to promote preventive dentistry for the individuals Bello Machre supports. Dental services are notoriously an underfunded service. The pilot program will help design a lasting program that provides better dental hygiene with a preventative approach for the people throughout the residential program.

Hertha S. and Jesse L. Adams Charitable Trust's continued generosity totaled **\$47,775** in support of the Hertha and Jesse Adams Ray of Hope Program. This program helps families in our community and individuals we support with unfunded items such as physical and occupational therapy, co-pays for medical appointments, prescription medication, summer camp expenses, adaptive equipment, and transportation to out-of-state specialists. The Adams Charitable Trust has partnered with Bello Machre for over twenty years and has given close to \$970,000.



Thanks to Ray of Hope funding, Vera was able to attend therapy sessions to identify sensory needs and build stronger motor skills.

Kathy and Jerry Wood Foundation continued its support of the Bello Machre Meaningful Day Program with a **\$25,000** grant. This grant helps young adults with developmental disabilities obtain job skills training and community job placement. The Kathy and Jerry Wood Foundation has been a partner of Bello Machre for ten years, giving \$225,000 in grant funding.

Maryland Affordable Housing Trust (MAHT) awarded a **\$60,000** grant to Bello Machre in 2023 to purchase four, full-home generators for our Allan, Longview, Millersville, and Wohlgemuth homes. MAHT has funded projects for Bello Machre for ten years and has given over \$378,000.

Developmental Disabilities Administration (DDA) Competitive Grant awarded Bello Machre **\$255,019** to strengthen infrastructure to ensure quality person-centered services. The 2-year grant will help bridge the gap with software requirements needed to access the new electronic billing system through DDA. Included in the grant is the purchase of new laptops and tablets for staff to access real-time data in the field. The funding will also help develop training modules for staff to access the new DDA billing system as well as increased efficiency for more accurate and timely billing.




